NOTIFICATION FOR SELECTION OF CHIEF EXECUTIVE OFFICER (CEO) OF MAHABUBNAGAR DCCB

Applications are invited for filling up of the **post of Chief Executive Officer (CEO), Mahabubnagar DCCB** from suitable candidates who fulfil the following Fit and Proper Criteria prescribed by RBI/NABARD, on contract/deputation basis.

Fit & Proper Criteria prescribed by NABARD/RBI

I. Age

The Applicant shall not be above **62 years of age** as on the date of appointment.

II. Qualifications

The person to be appointed as CEO shall at least be a:

- i. Graduate with CAIIB/DBF/Diploma in Cooperative Business Management or equivalent qualifications; or
- ii. Chartered/Cost Accountant; or
- iii. Post Graduate in any discipline.

III. Experience

The applicant shall have at least **Eight (8) years of work experience at the Middle/Senior level** in the Banking Sector (documentary evidence pertaining to the proof of having worked in the Middle/Senior level for the required period shall be **enclosed**).

Other Conditions

1. Proficiency in Telugu is essential.
2. The appointment shall be for a period of at least 3 years on deputation/contract basis.

3. SCALE OF PAY:

- 59170-1650/2-62470-1800/2-66070 with no stagnation increments.

Further, for the CEOs selected under Fit and Proper criteria from the same or any DCCB of Telangana state or TSCAB, 15% on the Basic pay+ DA drawn, will be given as special allowance which does not carry any further allowance on this special allowance.

- Perks and allowances will be extended, as decided by the Board of Management of Mahabubnagar DCCB.
4. The application should be submitted in the prescribed format only.
 5. Candidates fulfilling the Fit & Proper Criteria prescribed by RBI/NABARD working in Government/ Public Sector Undertakings/ Autonomous Organizations/ Cooperative/ Voluntary Organizations should apply through Proper Channel. They may submit advance copies before the last date, to avoid any delay in forwarding of their applications.
 6. In case of candidates who have resigned or taken voluntary retirement from service, other-wise eligible as per the Fit & Proper Criteria, they have to submit their relieving certificate and other relevant records required for the purpose.
 7. A recent passport size photo is to be pasted on the application in the space provided.
 8. Self-Attested copies of certificates pertaining to proof of **date of birth, qualifications, experience** and other credentials are to be enclosed to the application.
 9. Applications not complying with the conditions of Age, Qualifications, Experience, fees, employer recommendations, etc., will be summarily rejected.
