1. The Agency shall deploy well trained and disciplined Security Guards from the date of receipt of the agreement.

2. **Number of Guards Required:** There are 5 Security Guards, including one Armed Security Guard (Gunmen).

(Morning Shift- 3 Security Guards (including 1 armed gunman) and Night Shift 2 Security Guards).

➤ **Guard Qualification:** Must be physically fit and medically examined. Should be familiar with basic security protocols and bank premises monitoring.

➤ **Armed Security Guard (Gunmen):** Preferably ex-servicemen or trained guard with valid license to carry firearm. Must hold valid Gun License issued by competent authority.

➤ **Firearm requirement:**

- Armed Security Guard (Gunmen) must carry a licensed firearm (preferably 12-bore gun/revolver).

- License copy and details of the weapon must be submitted along with The bid.
  - Weapon maintenance, licensing, and usage compliance is the sole responsibility of the agency.
- ✓ The agency shall deploy personal below 55 years of age with robust health.
3. **Uniform & Equipment:** The agency should provide uniforms to the security with identity cards.
  4. **Service Period:** The outsourcing employment services for the period of one year from to extendable by one more year subject to the satisfactory services of the Agency.

6. The security provided by the First party to the Second party is to minimize the risk of crime and maintain law and order. So in case of any theft, pilferage etc, occurred during the currency of the contract then a proper police complaint shall be lodged by the Second party and copy of the same shall be given to First party also, in order to investigate and recover the material



which has been lost by the Second party. First party agreed to provide security at Head Office of the bank or any place as required by the Second party.

7. The security Guards once deployed should not be changed and in case of such changes, it should be done with the prior permission from the Chief Executive Officer, The District Co-operative Central Bank Ltd., Head Office, Mahabubnagar.
8. The Agency has to ensure fulfilment of all provisions of the Acts and Rules of the State Government and other relevant regulations made from time to time with respect to the provision of Contract Labour Act, payment of minimum wages, EPF, ESI, GST etc., and submit the proof of payment at the time of submitting of monthly bills.
9. The monthly bill of the contract amount shall be paid to the Agency (First party) only after submission of proof of statutory payments of EPF, ESI and GST of the preceding month to enable this office (Second party) to release the wages.
10. The Agency (First party) has to Quote the service charges on the remuneration to be paid on outsourcing personnel.
11. The Agency has to maintain register/records as required for verification during the inspection by the respective authorities.
12. The security deposit amount is refundable on the expiry of the period of contract without interest and subject to the agreement conditions.
13. In the event of the death of the proprietor or partner of the Agency (First party), the validity of the contract shall cease to exist. However, Second party may permit the legal heir of agency to continue contract on the same terms and conditions for the remaining period of contract on execution of fresh deed of agreement.
