General Instructions



A tender quotations are invited from eligible bidders for the supply of chairs for the auditorium and conference hall.

Tender details:

1. Bids have to be submitted through sealed quotations as per specifications and designs provided by the bank.
2. Application fees of Rs. 2000/- (Non-refundable) should be paid before submission of bids for all works combined through NEFT/RTGS in favor of:
 - n) The District cooperative Central bank Ltd., Mahabubnagar
 - o) A/C No: **140120100000004**
 - p) IFSC Code: **TSAB0014001**
 - q) Branch: **Head Office, Mahabubnagar.**
3. An EMD amount of **25000/-** (Rupees Twenty five thousands only) must be paid by the successful bidder after finalizing the bids, which will be refunded after Six months of completion of work through DD in favor of: The District Co-operative Central Bank Ltd., Mahabubnagar.
4. No Modifications, over writings or corrections can be made in the tender papers by the tenderer, but may at his option offer his comment or modifications in a separate sheet of paper attached to the original tender papers.
5. The Bank reserves the right to reject any tenderer or all of the tenderers without assigning any reason.
6. The tenderers should note that, tender is strictly on the item rate basis and their attention is drawn to the fact the rates for each and every item should be correct, workable and self – supporting. If called upon by the bank, detailed analysis of any or all the rates shall be submitted. The bank shall not be bound to accept the contractor's analysis.
7. The Specifications mentioned is approximate measurements. The works will be paid for as “measured work” on the basis of actual work done and not as “lump sum” contract.
8. The successful contractor is required to sign agreement as may be drawn up to suit the local conditions and shall pay for all the stamps and legal expenses incidental thereto. The original will be kept with the Bank and duplicate with contractor.

9. Should the work be not completed to the satisfaction of bank within the stipulated period, the contractor shall be bound pay the bank a sum calculated as given below by way of Liquidated Damages after the expiry of completion date.

Note: 1.00% of the estimated amount shown in the tender per week subject to a ceiling of 10% of the accepted contract sum.

TIME PERIOD FOR COMPLETION: 25 days from the date of award of work for each work.

10. Bidders have to provide details like firm's registration, GST, Registration Certificate, PAN numbers and Contact address, phone numbers & government identification proofs along with the tender documents.

11. Bidders have to submit work orders for previously executed similar works in the last three years.

12. Banks decision will be final in the Tender process.
